You are required by law to disclose certain political donations to the NSW Electoral Commission and to provide the information requested in this form. There are penalties for failing to disclose political donations or failing to lodge a disclosure as required. The information collected is held by the NSW Electoral Commission and accessible by relevant staff and its contractors.

Please note that the information in this form, and copies of this form, will be published on the NSW Electoral Commission’s website as required by law and may be made available for public inspection on application. We will disclose your personal information to other persons or entities if we are lawfully authorised or required to, for example, to other relevant investigative agencies for law enforcement purposes.
