Who needs to complete this form

The person responsible for a candidate:

- in a State election, where the candidate is a member of a State registered NSW party the party agent.
- in a local government election, where the candidate is a member of a local or State government registered NSW party the **candidate** OR with agreement the **party agent**.
- who is not a member of a registered NSW party the **candidate**.

What needs to be disclosed

Use this form to disclose political donations received or made, including:

- small political donations (under \$1,000);
- reportable political donations (\$1,000 or more);
- annual or other subscriptions paid to a NSW party;
- contributions, entry fees or other payments to participate in a fundraising venture or function;
- reportable loans (\$1,000 or more); and
- contributions made by the candidate to their campaign account.

A political donation made by a person or entity of less than \$1,000 is to be disclosed as a reportable political donation if that donation and other, separate political donations made by the person or entity to the same recipient within the same financial year (from 1 July – 30 June) would, if aggregated, total \$1,000 or more.

When to submit

Return completed form **by 11 August 2024**, using the contact details at the bottom of this page. Penalties apply for failing to comply.

All pages of this form need to be submitted, even if there is nothing to disclose on a particular page.

The information collected is held by the NSW Electoral Commission and accessible by relevant staff and its contractors.

Please note that the information in this form, and copies of this form, will be published on the NSW Electoral Commission's website as required by law. Copies or extracts of other documents provided in connection with the claim may be provided for public inspection on application. We will disclose your personal information to other persons or entities if we are lawfully authorised or required to, for example, to other relevant investigative agencies for law enforcement purposes.
