

Constitution Central Coast Heart Local Government Political Party
formerly Save Tuggerah Lakes

1. The Party shall be henceforth called Central Coast Heart with a official abbreviation of CC Heart for election purposes.
2. The Party shall advocate for the good governance of the Central Coast region and to that end stand candidates in the Central Coast Council local government elections.
3. Membership of the party is open to any person who in the opinion of the executive can assist the party in achieving its goals. Members who no longer in the opinion of the executive share these goals may be removed by the executive from membership.
4. The affairs of the Party are to be managed by the executive consisting of the President , The Vice President and the Party Agent.
5. The offices of President and Vice President shall be elected by the members at an annual general meeting of members to be held every 2 years no later than 31 December.
6. The Executive shall convene such other general , special and executive meetings as they think fit.
7. The President and Vice President shall appoint the Party Agent who is responsible for ensuring the Electoral Expenditure and Donations returns are made and records kept. The current party agent is Hongyi Yang.
8. The Party's constitution may be amended by resolution of the majority of the members passed at a general or special members meeting of which 7 days notice has been given to members and may be called by either the executive or by a notice signed by 10 members and delivered to the President.

applicants for membership shall fill in an application form and pay the current membership fee, the party executive will determine whether to confer membership on the applicant in their absolute discretion. The executive will send a show cause notice to any member whom they believe is not a fit and proper person to be a member, the member shall have 14 days to respond to the notice, the executive shall consider the response and determine whether in their absolute discretion the persons membership is terminated.

(v) the procedure for selecting a person to hold an office in the party and for removing a person from office:

Officers of the party are elected at party AGMs as set out in the constitution. A party official may be removed from office by a requisition for an extraordinary meeting signed by at least 10 party members, followed by the extraordinary meeting to be convened between 14-21 days after receiving the requisition and then by a majority of votes passed for the officers removal at that extraordinary meeting, and following any such removal the meeting will then call for nominations for appointment of a replacement and then elect such replacement at the meeting.
