## **Claim for payment from the Election Campaigns Fund - Candidate**

This form applies to a candidate who is making a claim for payment from the Election Campaigns Fund under Part 4 of the Electoral Funding Act 2018, in respect of expenditure incurred by the candidate in connection to a State election.

This form must be accompanied by a Payment Authority for Election Campaigns Fund - State election (EF.686).

Privacy The NSW Electoral Commission has obligations under privacy legislation, including about collecting, managing, and storing personal information. The personal information collected on this form or included in any other documentation, information or evidence you provide in connection with the claim will be used by the NSW Electoral Commission to undertake its statutory and administrative functions relating to claims for funding, including to verify your eligibility and determine your claim. We may also use it to update your contact details in our records, conduct inquiries to verify information that you have provided to us, send you relevant notifications or reminders (including via sms or email), provide information about your statutory obligations or invite you to participate in relevant surveys or information seminars. If you wish to make a claim, you are required by law to provide the information requested. Not supplying all the information requested may delay or prevent the processing of your claim. The information collected is held by the NSW Electoral Commission and is accessible by relevant staff and its contractors.

Please note that claims for payment from this fund are published on the NSW Electoral Commission's website and that copies or extracts from other documents provided in connection with the claim may be provided for public inspection on application. We will disclose your personal information to other persons or entities if we are lawfully authorised or required to, for example, to other relevant investigative agencies for law enforcement purposes.
