What needs to be disclosed

Electoral expenditure incurred in the annual period is expenditure for or in connection with promoting or opposing, directly or indirectly, a party or the election of a candidate or candidates or for the purpose of influencing, directly or indirectly, the voting at an election.

When to submit

Return completed form **no later than 22/09/2024**, using the contact details at the bottom of this page. Penalties apply for failing to comply.

All pages of this form need to be submitted, even if there is nothing to disclose on a particular page.

How to complete this form

Section 1 (in red) is mandatory and must be provided.

Declare whether you have anything to disclose on page 1 by checking the relevant box. If you don't have any electoral expenditure to disclose, only page 1 needs to be completed and submitted. If you have electoral expenditure to disclose, you must submit all pages of the form by completing section 2 (in blue) even if you don't have items added to that page. The information collected is held by the NSW Electoral Commission and is accessible by relevant staff and its contractors.

Please note that the information in this form, and copies of this form, will be published on the NSW Electoral Commission's website as required by law. Copies or extracts of other documents provided in connection with the disclosure may be provided for public inspection on application.

We will disclose your personal information to other persons or entities if we are lawfully authorised or required to, for example, to other relevant investigative agencies for law enforcement purposes.
