

## Withdrawal of a candidate

## **Local Government election**

Section 291 of the Local Government (General) Regulation 2021

To withdraw your nomination, you are required by law to personally sign a notice in writing. We require the form to be completed to enable us to process your withdrawal. This form cannot be amended once it is lodged.

**Privacy statement:** This form will be used by the NSWEC **(us)** to process the withdrawal of your nomination and to support our statutory and administrative functions including maintaining our records relating to elections, public funding, political donations and electoral expenditure. The information you provide is held by us and accessible by relevant staff and our contractors. It may also be disclosed to other persons or entities if required or authorised by law. If you want to withdraw your nomination, you are required by law to personally sign a notice in writing. We require the remaining fields be completed to enable us to process your withdrawal.
